



Scope of Work

Demolition and Site Preparation:

- Remove damaged stucco from approximately 1000-2500 square feet of exterior wall surface
- Expose and assess substrate damage behind failed stucco areas
- Clean and prepare work area, including debris removal and site protection
- Protect adjacent surfaces, windows, and landscaping with plastic sheeting and drop cloths

Substrate Repair:

- Repair significant damage and rot in substrate behind stucco areas
- Repair or replace damaged window and door trim affected by stucco failure
- Ensure proper flashing and moisture management details around openings

Three-Coat Stucco Application:

- Apply scratch coat (first coat) to prepared surfaces with proper thickness and scoring
- Apply brown coat (second coat) with proper float finish and curing time
- Apply finish coat (third coat) with texture matching to match existing stucco patterns
- Ensure proper curing between coats and maintain consistent thickness throughout
- Match existing stucco texture and profile on 1000-2500 square feet of surface area

Color Matching and Final Paint:

- Color match existing stucco finish to ensure seamless appearance
- Apply primer coat suitable for stucco surfaces
